### **Contest Rules**

- ◆ Applicants must be high school juniors or seniors.
- ◆ Applicant's parents must be members of the Bartlett Electric Cooperative or an employee of the Bartlett Electric Cooperative, Inc.
- ◆ Applicant must reside in the home of parents who are employees or full-time residents of a home serviced by Bartlett Electric Cooperative.
- ◆ Applicant's must submit one completed application along with an essay of not more than 500 words in length, 12-point type and double spaced on the following topic:

***What is an Electric Cooperative, and Why is it Good for America and Your Community?***

- ◆ The essays must be typed, no handwritten entries will be accepted.
- ◆ The essays may be delivered to the Bartlett office at 27492 Hwy 95, Bartlett TX or mailed to:

- ◆ Essays must be received in the office no later than 5:00 p.m. on **February 12, 2010**.

### **The Selection Process**

- ◆ A panel of judges will select three finalists from the written essays submitted.
- ◆ The finalists will give oral presentations of their written essays before an independent panel of judges.
- ◆ If you are chosen as a finalist but find that you are unable to participate in the trip, please advise Bartlett Electric Cooperative as soon as possible.
- ◆ The dates for next year's tour are June 10-18, 2010.
- ◆ A runner-up will represent Bartlett Electric on the trip in case the winner is not able to attend.
